1. Introduction

At 3:15pm on 28 February 2014 we, Mark Hector Norrie, Insolvency Practitioner of Auckland and Pamela Louise Jenkins, Insolvency Practitioner of Auckland were appointed liquidators of Hamills Auckland Limited (in liquidation) by a special resolution of the company's shareholders.

This report has been prepared in accordance with section 255(2)(d) of the Companies Act 1993 for the purposes of reporting on the conduct of the liquidation during the preceding 6 months and reporting of further proposals we have for completing the liquidation].

The statements and opinions expressed in this report have been made in good faith and are based on information available as at the date of this report. We have not conducted any form of audit in respect of the Company. In preparing this report we have relied on information made available to us. We have not independently verified, and express no opinion as to, the completeness, reliability or accuracy of that information. We reserve the right, but will be under no obligation, to review or amend our report if it subsequently comes to light that information we have relied upon is incomplete or inaccurate.

2. Report on the Conduct of the Liquidation During the Preceding 6 months

Assets

The Company's assets included the stock, goodwill and other assets of its trading operation trading under the franchise name Hamills and located at Cavendish Drive Manukau City Auckland. The company also owned franchise rights in other locations.

An evaluation of the assets concluded that a sale as a going concern would produce a better return for creditors than a discontinuance of trading and the fragmented sale of assets. A sale of the business as a going concern was completed on 31 March 2014. Details of the sale price and trading are commercially confidential and not disclosed.

Distributions

Secured creditors and employee unpaid wages have been paid. Costs associated with running the business and the protection and sale of assets have been paid. Refer to Appendix A for a Statement of Realisations and Distributions.

Accounts

The Company accounting records have been reconstructed and the time of insolvency established.

3. Further Proposals for Completing the Liquidation

Creditor Claims

Secured creditor claims totalling \$400,589.86 have been received.

Five preferential creditor claims totalling \$49,344.70 have been received.

Unsecured creditor claims received total \$278,917.72.

Claims have also been received in respect to goods sold on consignment and layby.

All secured creditors have been settled in full and subject to the outcome of and the costs incurred in the recovery of antecedent transactions the liquidators current opinion that preferential creditors will be paid in full and a distribution likely to be between 5 and 8 cents in the dollar will be available to unsecured creditors. The timing of any distribution to unsecured creditors has not been determined but realistically will be at least 12 months from the date of this report.

Investigations

The Liquidators are currently investigating the books records and affairs of the Company.

The Liquidators have identified a number of voidable preference transactions and are currently pursuing. Some creditors were paid in full when the Company was insolvent. It is expected litigation costs will be incurred.

A number of other investigations are underway including one prosecution. Transactions involving shareholders and ex-shareholders and/or associated parties are under investigation and/or proceedings.

Further Distributions

Preferential creditors will receive further distributions.

Unsecured creditor distributions will be reliant upon the outcome of voidable preference claims.

Creditors List

The Liquidators were unable to produce a list of creditors in their first report because the Company creditor records were not available in sufficient time and were discovered to be unreliable and omitted certain creditors. The list of known creditors is attached to this report. Refer to Appendix B for a list of known creditors.

4. Estimated Date of Completion

It is not practical to estimate the time in which the liquidation will be completed.
