#### 1 Introduction

At 8:00am on 10 June 2015 Mark Hector Norrie, Insolvency Practitioner of Norrie & Daughters, Penrose, Auckland was appointed liquidator of Gupta Land Limited (in liquidation) by a special resolution of the Company's shareholder.

This report has been prepared in accordance with section 255(2)(d) of the Companies Act 1993 for the purposes of reporting on the conduct of the liquidation during the preceding 6 months and reporting of further proposals we have for completing the liquidation.

## 2 Report on the Conduct of the Liquidation During the Preceding 6 months

## Assets

The Company disposed of all Company assets prior to liquidation however the liquidator has identified potential transactions that are voidable or otherwise claimable.

### Distributions

The liquidator has not made any distributions.

## 3 Further Proposals for Completing the Liquidation

The liquidator is investigation the actions of the ex and current director, deemed directors and related party transactions.

Documents have been obtained from various parties.

Investigations show that the Company appears to have failed to maintain records as required under ss 189 and 194 of the Companies Act 1993 and has failed to comply with certain sections of the Tax Administration Act 1994.

Claims based on voidable transactions and related party transactions are being considered and further investigation continues.

Relevant Government agencies will be advised of issues arising in the course of the liquidation that require the agency to be informed.

A list of known creditors is annexed to this report as creditors were unknown at the time of the first report.
