CONDUCT OF THE LIQUIDATION

Settlement of a voidable transaction against the company was accomplished and with the benefit of hindsight the settlement of 77.35 cents to the dollar claimed was a very favourable settlement for the shareholders of the Company when viewed against the interim Court of Appeal Judgment in favour of Contract Engineering Limited (In Liquidation) in respect to other similar voidable transaction claims.

The Company has lodged with the liquidator of Contract Engineering Limited (In Liquidation) an unsecured creditor's claim for the equivalent amount of the settlement sum and the claim has been admitted into the liquidation of Contract Engineering Limited (In Liquidation).

Matters relating to how the Company treated its GST calculations with a related company are still subject to discussion with IRD and as a result a current debt to IRD exists however notwithstanding debt it is probable that the liquidation will conclude as a solvent liquidation.

REALISATION OF ASSETS

No assets were realised.

CREDITOR CLAIMS

An outstanding GST debt is under negotiation with IRD

INVESTIGATIONS

No new matters require investigation.

For commercial reasons the settlement sum with Contract Engineering Limited (In Liquidation) is not disclosed.
